Opening Kick-Off Session – THE CASE FOR OPERATING ETHICALLY?

GOOD ETHICS AND GOOD CORPORATE GOVERNANCE: ARE THESE ESSENTIAL FOR THE BOARD ROOM OR JUST A “NICE TO HAVE?”

Business ethics comprise the moral and ethical beliefs and value systems which direct behaviors and decision making. Ethical requirements have been embodied into law ever since Moses began stone masonry on Mount Sinai. In our modern era, many ethical requirements are codified into law – e.g. duties to creditors, minimum wage, FCPA, UK Bribery Act, anti-trust, data protection, human rights and environmental regulation. Every corporation's leadership team has a vital role to play because the ethical stance of any business is only effective when it begins with the “tone from the top.” Through management philosophies based on ethical principles of business and behavior, an example and statement of purpose is set for all to follow. When done well, this then permeates through the organization and its supply chain guiding employees and others in making the right decisions for themselves and the business. Rather than slowing down the speed of corporate action, clear ethics and governance can lead to faster decision making, increased productivity and higher morale. A business that demands high standards of business ethics, will also require high-performing employees who are more likely to stay in a business that is itself high-performing, as this will build the brand. This interactive program will include headline grabbing examples from global business while focusing on corporate governance, rules and practices that can impact a company's many stakeholders and have a direct impact on the company culture, reputation and financial success.

There are laws that promote good behavior by imposing penalties (including prison): FCPA, UK Bribery Act and the regulation of remuneration in financial services to name just a few. In this interactive session, we will consider various laws and discuss how you can reward good behavior in order to promote ethical behavior, even if it means paying an executive or employee a bonus for doing their job right. KEEPING SECRETS SECRET: HOW TO ENSURE THAT CONFIDENTIAL INFORMATION REMAINS CONFIDENTIAL

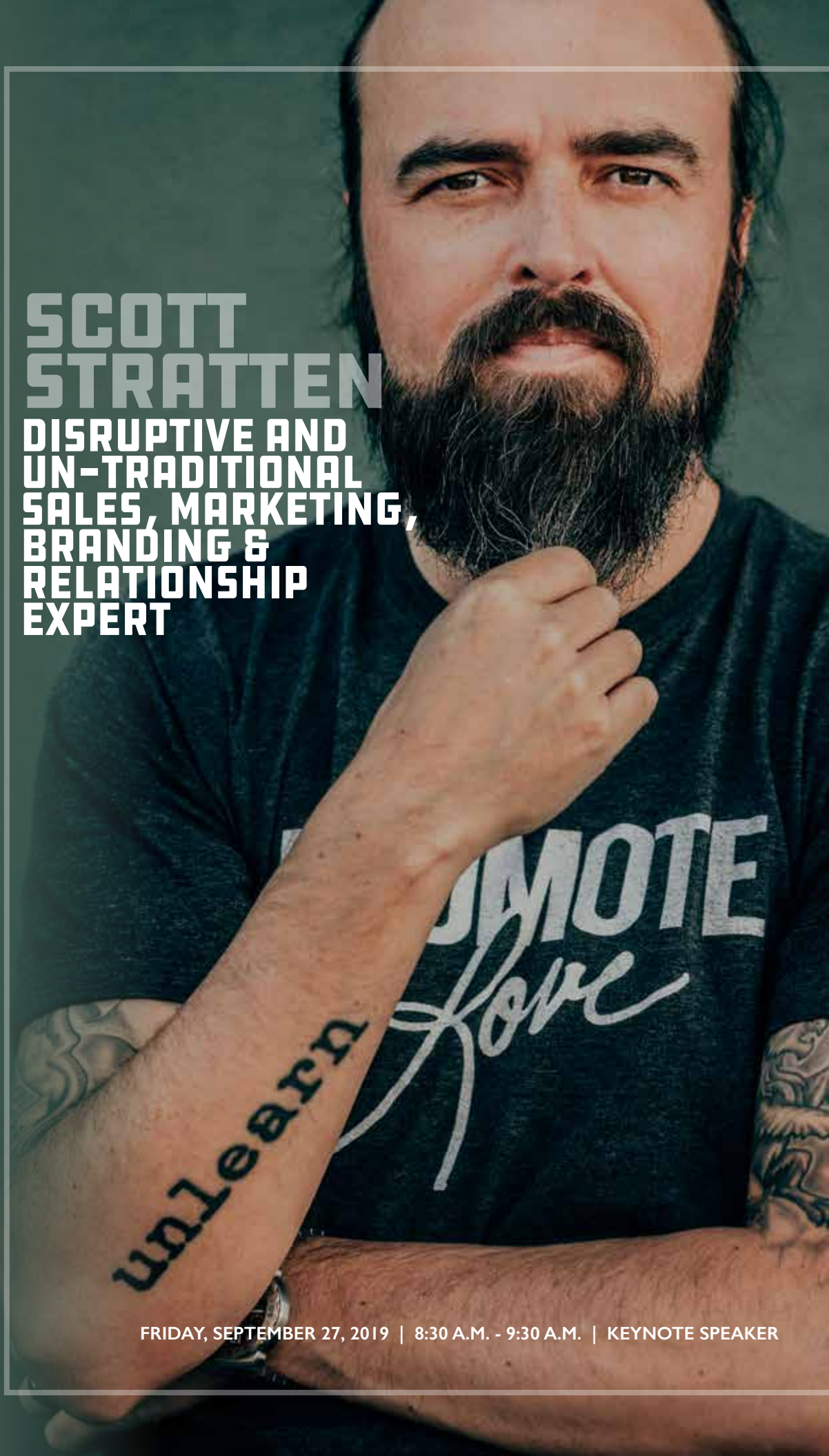

ARTIFICIAL INTELLIGENCE: WHAT IT MEANS TO THE LEGAL INDUSTRY AND TO YOUR BUSINESS

Artificial Intelligence (“AI”) is here and it is starting to transform industries across the spectrum of products and services, including the legal industry. In this session, we will explore how AI is disrupting the legal industry in areas such as document review, legal research, due diligence, contract review and management, and even in predicting legal outcomes. We will discuss the benefits and pitfalls of AI and what you need to know to effectively adopt and use AI in your business and in your law firm.

“THAT’S NOT FAIR!” – UNFAIR BUSINESS PRACTICES AND WHAT YOU CAN DO ABOUT THEM

There is nothing more infuriating than building a successful business only to have competitors utilize unfair business practices to undermine that success. In this track we will explore the strategies you may use to counteract unfair business practices, including registration and enforcement of intellectual property, use and enforcement of non-compete and non-disclosure agreements, and how to address false and misleading advertising.

ALTERNATIVE DISPUTE RESOLUTION: THE ADVANTAGES AND DISADVANTAGES OF ARBITRATION AND MEDIATION

Alternative Dispute Resolution (“ADR”) can be effective in avoiding the uncertainty and expense of litigation, but ADR is not without pitfalls. We will explore the advantages and disadvantages of arbitration and mediation and how to draft and enforce effective ADR contract provisions. We will also discuss how to select potential neutrals or arbitrators and how to enforce ADR decisions. Finally, we will hear from seasoned litigators on lessons learned in ADR proceedings.

RECENT DEVELOPMENTS IN INTERNATIONAL COMPETITION LAW: WHAT YOU NEED TO KNOW TO MAINTAIN MARKET COMPETITION

International competition laws are written and enforced to maintain market competition by regulating anti-competitive conduct by companies. However, for companies that produce and promote products and services across international borders, competition laws can be difficult to understand and harmonize. Our panel will explore cross-border competition considerations and discuss points to remember when conducting business in North America and Europe.

GENERAL COUNSEL FORUM: WHAT OUTSIDE COUNSEL NEED TO KNOW

This panel of USLAW client general counsel will discuss what they look for when hiring and using outside counsel. NUCLEAR VERDICTS IN PRODUCTS LIABILITY CASES: WHAT YOU NEED TO KNOW

Jury verdicts for products liability cases have been on the rise with tens of millions being awarded in compensatory damages and hundreds of millions being awarded in punitive damages for a single case. Just this month, a jury awarded over \$2 billion in damages to a couple claiming that Roundup weed killer caused them to develop cancer. Plaintiffs' attorneys say they will continue to litigate these cases until companies start taking responsibility for the health effects of their products. This session will discuss the ramifications of these "nuclear" jury verdicts and provide methods for companies to protect themselves against such litigation.

JUST SAYING NO: THE SUCCESSES, PERILS AND PITFALLS OF BELIEVING IN YOUR PRODUCT AND HOW IT CAN AFFECT LITIGATION

Plaintiffs' attorneys continue to become more aggressive and expect that every defendant will litigate and settle cases on their terms. When a defendant just says "no," it often rocks the world of both the plaintiff and the other defendants because they simply are not used to it. Product manufacturers rightfully say "no" and stand up for their products more than most defendants. This session will interactively discuss how truly standing up for a product rejects the all-too-common playbook and changes the tenor and strategy of a claim and case. During this interactive session clients, counsel and corporate partners will share their experiences and best practices for successfully and effectively just saying no.

PRODUCT LIABILITY IN THE INFORMATION AGE: MILLENNIALS, DISINFORMATION CAMPAIGNS, AND PRODUCT WARNINGS/USER MANUALS IN THE AGE OF THE INTERNET

The information available to consumers has changed drastically in the age of the internet. More and more, consumers will look to the internet as their first source of information about a product. Many companies publish their official user manuals and product warnings online. However, there is also an overwhelming host of information and disinformation disseminated through websites, YouTube, and social media plat-

forms. This session will delve into the practical and legal implications of keeping up with the ever-evolving information age. Additionally, we will discuss how the culture of "trending," "memes," "influencers" and "internet challenges" (such as the Tide Pod Challenge) might impose new duties and previously unforeseen exposures upon product manufacturers.

PRODUCT RECALLS AND CRISIS MANAGEMENT: HOW TO PROTECT YOUR COMPANY DURING THE AGE OF MODERN MEDIA

A major product recall can become a nightmare for a crisis management team. And, social media is the double-edged sword of managing the crisis. Platforms like Facebook, Twitter, and Instagram can be an essential communication tool for effectively managing the crisis – but they can also make a crisis worse than ever if they are not used strategically. In the digital-social media age, scandals are spread and remain memorialized a few clicks away. This session will review steps which will assist with preparing for and managing a product recall crisis.

PRE-LITIGATION STRATEGIES FOR PREVENTING SPOILIATION OR MISSING EVIDENCE TRAPS IN ORDER TO AVOID NIGHTMARE SETTLEMENT NEGOTIATIONS AND VERDICTS

Parties have a duty to preserve evidence as soon as litigation is reasonably foreseeable, which can be well before a complaint is filed. Failing to preserve evidence can result in sanctions, including monetary sanctions, and can severely impact settlement negotiations, while greatly increasing litigation expenses. To avoid this, claim professionals need to take specific actions and implement policies to avoid spoliating evidence. This ranges from securing the incident scene and collecting and preserving physical evidence to retaining electronically stored information. This session will present examples of how litigation and settlement negotiations can go awry due to spoliation of evidence and will offer comprehensive solutions to avoid these traps on the front end.

EMPLOYMENT LAW HOT TOPICS

In this fast-paced and interactive session, panelists will address current issues and hot topics impacting the employment and labor law arena. New development and trends in the following areas will be addressed: medical/recreational marijuana updates; independent contractors/gig economy issues; California/New Jersey/key state updates; wage/hour – updates and proposed regulations; and arbitration/class action waivers.

ETHICAL ISSUES FOR IN-HOUSE LABOR/EMPLOYMENT ATTORNEYS

The #metoo era has brought new ethical challenges to in-house employment attorneys. In this session, we will cover internal investigations, new technology, use of social media, and workplace issues in the legal department.

REIGNING IN DISCOVERY AND LITIGATION COSTS

INSURANCE FOR PROPOSAL SETTLEMENTS AND COSTS OF LITIGATION

There are new insurance and litigation financing products that are being marketed to reduce the risk plaintiffs (and their counsel) take when litigating and trying cases. These include products to insure the loss of a case at trial and to finance litigation for a percentage of the settlement or verdict in the case. The panel will discuss how these products can impact the defenses' ability to timely and reasonably settle cases, how they can create issues as to who the true decision-makers are regarding case strategy and settlement, and how they open up potential waiver of privilege arguments defense attorneys can use in certain cases.

DEPOSITION PREPARATION FOR PROFESSIONAL DEFENDANTS AND 30(B)(6) DEponents

The deposition of the professional defendant is still one of the – if not the – most important event in any professional liability defense case. The days of instructing clients to stick to “yes,” “no,” “I do not know,” or “I do not remember” answers are over. The panel, which will include a witness consultant and defense counsel, will discuss the importance of preparation and practice sessions, selling case themes throughout the deposition, combatting plaintiff's counsel's attempts to get the damning sound bite, and other important witness preparation advice. The panel will also discuss Rule 30(b)(6) depositions and how to identify and effectively prepare a corporate representative for deposition.

E-DISCOVERY, AUDIT TRAILS, AND OTHER ISSUES SURROUNDING THE PRESERVATION AND PRODUCTION OF ELECTRONIC RECORDS

We all are transitioning to a paperless practice. Lawyers, doctors, accountants, and other professionals increasingly have electronic files they believe constitute their “official file.” However, the “official file” often includes other electronic

information such as video footage, phone data, audit trails, and incidental and collateral e-mails that are often the subject of discovery in this electronic age. This interactive session and panel will discuss how to handle the gathering and production of the electronic file, motion practice regarding the production of electronic files, how to address, handle, and object to audit trail and other similar requests, common spoliation of evidence arguments surrounding electronic files, and how to avoid creating the bad “paper” trail.

CONSENT POLICIES AND BAD FAITH

Consent policies in a professional liability setting frequently create tensions between the insured defendant and the insurance carrier given that issues of bad faith linger in the background when there is potential for an excess verdict. Given low policy minimum requirements on insurance for professionals in many states and rising expenses plaintiffs are seeking in their lawsuits, more and more professional liability cases are triggering potential excess exposure for the insured professional. This panel will discuss this growing trend, whether a consent policy is a consent to allow a settlement of the case or simply a consent to tender the policy limits, and how to combat plaintiff's counsel's attempt to drive a wedge between the carrier and insured.

TECH IN A COURTROOM

In this modern age, jurors expect their evidence to be in a technological form with fancy graphics and explanations in multi-colored, multi-media presentations. The panel will discuss how best to present a technologically competent case, effective products available to do so, the pitfalls that can plague any electronic presentation of evidence, and when an old-school foam board is still the best approach. The panel will also discuss the use of video depositions and how effective they are (or are not) when used to impeach a witness at trial.
